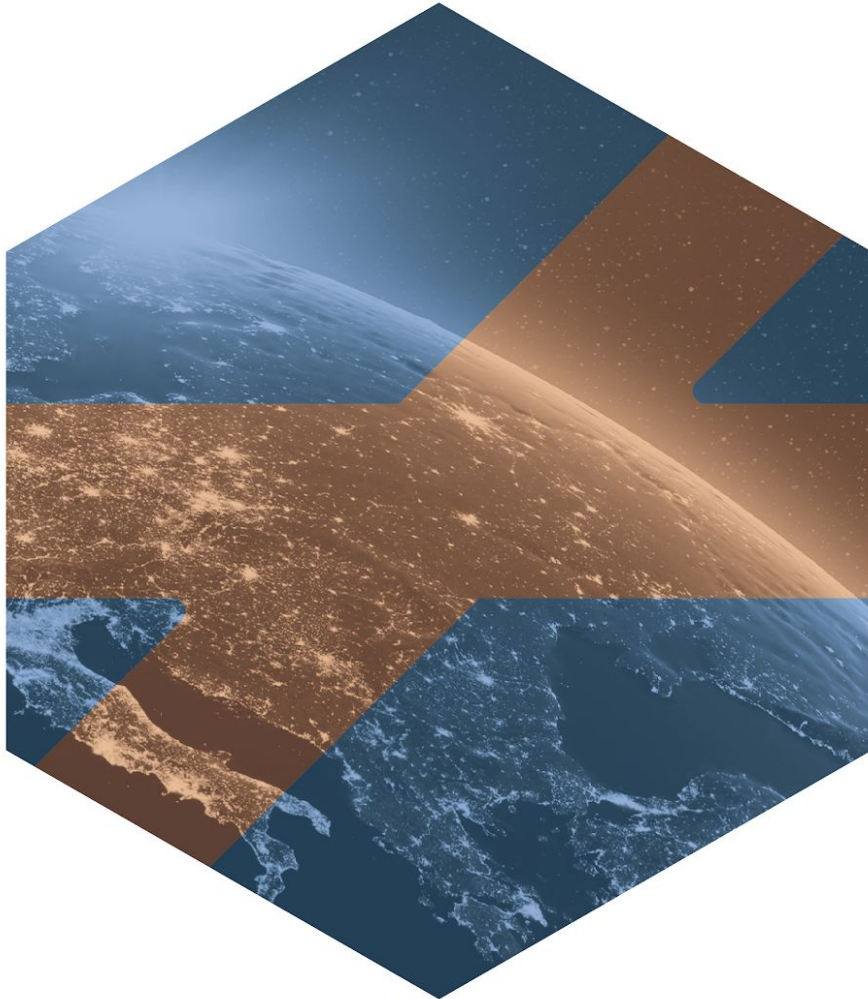

- 5-year property tax exemption

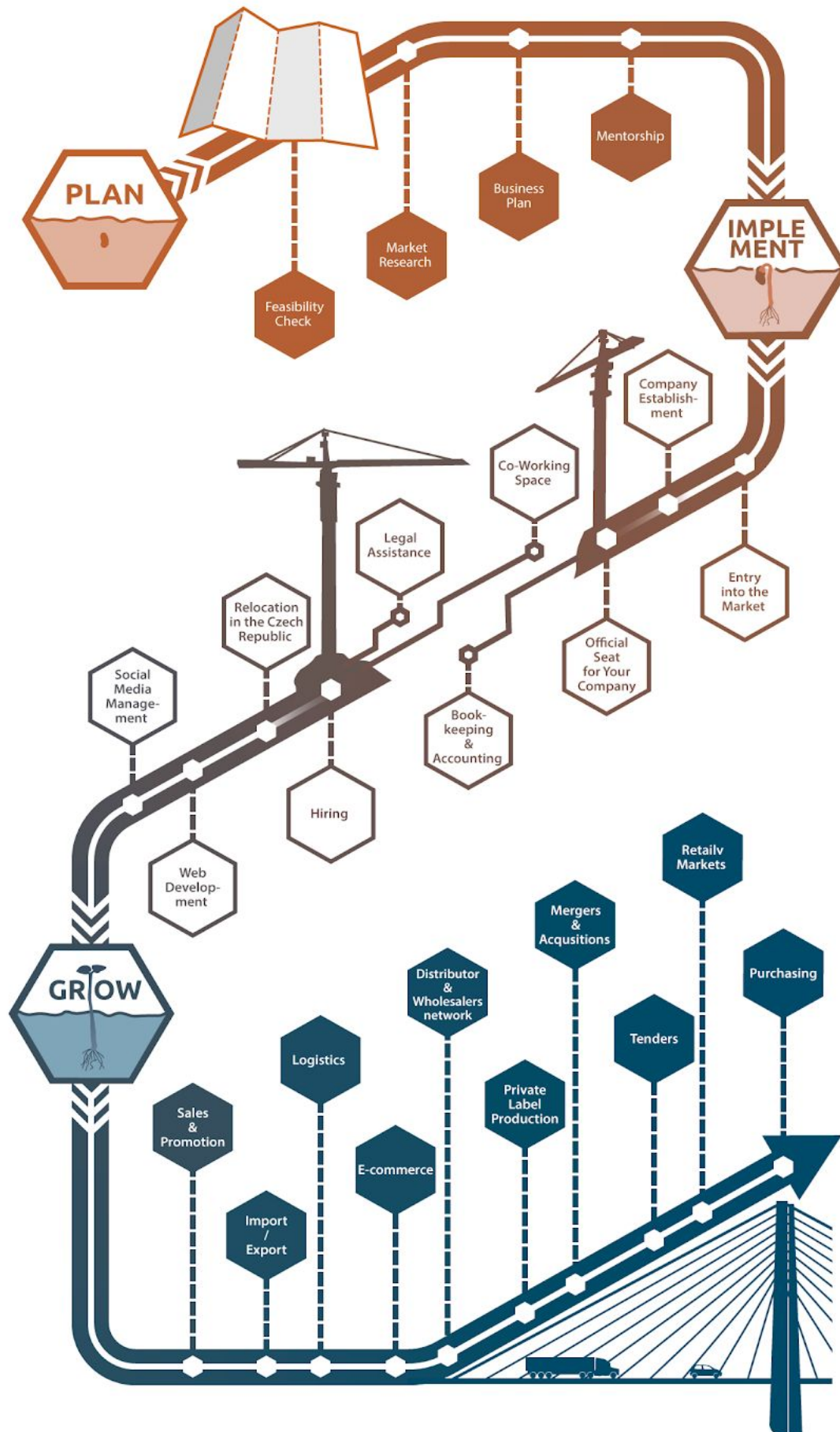
